

# Notice of 2025 Virtual AGM

Notice is hereby given that the 56th Annual General Meeting of members of the Anglo Medical Scheme will be held **virtually on Wednesday, 21 May 2025 at 10h00**, for the following business:

- To confirm the minutes of the 55th Annual General Meeting of the members of the Anglo Medical Scheme held on 22 May 2024.
- To receive and adopt the reports of the Board of Trustees and of the Auditors, and the Annual Financial Statements (AFS) of the Anglo Medical Scheme for the year ended 31 December 2024.
- To notify the meeting of appointees to the Board of Trustees for the ensuing year.
- To elect three members to the Disputes Committee in terms of the Rules of the Anglo Medical Scheme.
- To appoint Auditors in terms of the Rules of the Anglo Medical Scheme.
